## London chamber of commerce, Members 1823-4.

A London chamber was established in 1823 which survived for 2 years. It was active enough to mount several lobby campaigns, but its lack of success in gaining government backing and a charter put off the chamber leaders and it fell into disuse. This nevertheless constitutes the first significant attempt to establish a London chamber with a broad membership. A first London chamber of commerce had been established by John Weskett and existed over 1782-1800. However, this was essentially a one-man operation that chiefly focused on arbitration of commercial disputes. Several later attempts were made to establish a London chamber, but they did not finally succeed until the modern chamber was founded in 1882 (see R. J. Bennett (2011) *Local Business Voice*, OUP, pp. 100-101, 193-200).

The initial meetings of the chamber had 280 subscribers who signed their support; unfortunately this list does not survive. What does survive is the 55 names of the members of the standing committees of the chamber in 1823 and 1824, plus another 13 members whose comments are reported in chamber meetings: N=68 in total. This is 24% of the subscribers, and constitutes all the leading members from the chamber's committees.

The known membership is notable for the high number of MPs. This suggests that this first effort to develop a chamber, whilst attempting to cover the general business community, was more of a parliamentary grouping to draw together MPs who had a business interest in London and more generally.
